In December 2016 the Equality & Human Rights Commission launched a formal inquiry into housing for disabled people. The inquiry is examining the provision of accessible housing or housing that can be adapted to increase accessibility. The Commission would particularly like to hear from disabled people, their families and carers and have produced a questionnaire which focuses on the main areas of interest.
