The OneCity Trust – Grant Programme Applications

The OneCity Trust is pleased to announce that its main grant programme is now open for applications. Registered charities and constituted groups based in Edinburgh and focussing their work in the city. Ideally with an annual income of less than £200,000, are invited to apply for funding for equality and social inclusion projects meeting one or more of the following priorities Community Connectedness, Cultural Bridging and Civic Inclusion.

Applications for this funding will be considered from organisations that involve City of Edinburgh Council tenants or from other organisations aiming to benefit geographical areas with a high proportion of Council homes. Overall, the Trust intends to make up to 15 grants, of between £5,000 and £10,000. Please note that the Trust is supported by the council on a part-time basis. **The deadline for applications is Friday 20th April 2018**, and projects should commence on 2nd July 2018 and run for up to one year. Please note one off projects will also be considered. A condition of this funding agreement will be the promotion, media and photographic opportunities organised with the OneCity Trust, at any time throughout the period of the fund. You must also acknowledge the source of your funding at every opportunity, e.g. logos on websites, promotional materials, etc.
