THE BIG CONVERSATION: TENANTS DECIDE

The Theme



The Conference theme was ‘The Big Conversation’. As Betty Stevenson, Convenor of ETF explained: “The Conference was an opportunity for our members to talk openly about the big things that are important to ETF – especially in the year ahead which may be one of change. The 'Wicked Questions'

The 'Wicked Questions' centred on the following themes:

1. Who is the Federation for? What is our purpose? Do tenants still need ETF?
2. Our membership is based on tenants' groups and yet more individuals are getting involved;
3. We're a citywide organisation and we're doing more local work;
4. Are there any challenges and opportunities of ETF working in a contract with the Council?
5. How do we represent and support all tenants?

TENANT PARTICIPATION SERVICES: CO-PRODUCTION UPDATE

ETF has been involved with the City of Edinburgh Council and a number of other agencies over the summer to draft ideas about what a future service for tenant participation could look like in Edinburgh. Tenants had the opportunity to bring ideas forward to an event in the City Chambers in June 2016, and views from that meeting have helped to contribute to discussions with the Council.

ETF also assisted an Advisory Group of tenants in meeting with the Council. The Advisory Group has contributed positively towards generating ideas for the future of a tenant participation service. However, the group has also been critical of the timescales involved in the co-production process and commented that the Council event in June “did not make clear this was about the future of ETF and the Neighbourhood Alliance”.

The Federation agrees with these points and representatives have consistently said that the timescales in the co-production process are too short for tenants to actively take part. The Federation is also concerned that many tenants are unaware of the co-production process.

Federation staff currently provide support to tenants’ groups and individuals wishing to get involved in tenant participation, and it is this service (and that of the Neighbourhood Alliance), that the co-production group is considering the future of.

The Federation’s Conference in June considered what ETF Members require of a tenant participation service and Members were clear in outlining their priorities for the future.

Our Members:

- Value the **independence** of staff providing support to tenants and tenants' groups. A future service should be independent of the Council;
- See **no conflict** in the roles of ETF representing tenants and our staff providing support to tenants;
- See ETF as a **strong and independent tenants'** movement that is required to hold the Council as a landlord, to account;
- Agree that according to the law, the Council has a duty to **adequately resource** the Federation, including its role in campaigning for tenants' issues, as well as for support for the Executive Committee and the Federation as an organisation;
- Strongly believe that the model we currently have (where tenants set the Work Plan for staff and monitor progress every quarter) should remain. This gives **tenants control** over the tenant participation services and means it is our priorities that staff work to;
- Believe that a **citywide service** is still required to ensure that tenants have the opportunity to come together. And that **resources at the grassroots** for outreach support should be increased. Ideas for this included an Outreach Worker for each Locality in the city;
- Think that more could be done to support tenants who don't get involved currently, especially **younger, Black, Minority and Ethnic and Lesbian, Gay, Bisexual, Transgender tenants**;
- Want **learning opportunities** – especially with other tenants in informal and formal ways;
- Want **Tenant Led Inspections** to continue to be a priority and the focus to be on tenant participation in **housing services** with opportunities to link to other issues in our communities;
- Think **resources for tenant participation** should be increased.

These points have been presented to the Council by ETF representatives in the Co-Production Working Group (CPWG).

Councillors are due to consider options for the 'tenant participation and engagement services' in the Health, Social Care and Housing Committee at the City Chambers on **Tuesday 13th September 2016, 10.00am**. Papers for this meeting will be available a week in advance on the Council's website www.edinburgh.gov.uk. ETF intends to have a deputation at this meeting. This is an open meeting and all are welcome to attend.

ETF is unsure (at the time of going to press) what will be included in the papers for the Committee, or if any of the points ETF has made to the CPWG will be taken into account. Therefore our next Federation Meeting on **Monday 12th September 2016, 6.00pm-9.00pm, Norton Park Conference Centre** will consider the report and help set the Federation's position for the Committee meeting the following day. THANK YOU LYNNE



ETF would like to pay a special tribute to Lynne Tait who has stepped down from the Federation's Executive Committee after nearly 20 years. Lynne has been a real stalwart for ETF and in her local community of Southhouse and Burdiehouse, by being Chairperson of Southhouse and Burdiehouse Residents Organisation (SABRO) over many years and she will be a huge loss to the Executive Committee. For this edition of *Tenants Voice*, we have asked Lynne a number of questions relating to her work with both her group and ETF over the years.

How long have you been involved with Edinburgh Tenants Federation?

I have been involved with the Federation since 1997.

What made you become involved with the tenants' movement?

Through my own tenants' group I attended a meeting of the South Edinburgh Residents Council, where George McKie, who was ETF's Convenor at the time, was in attendance. He persuaded me to attend the Federation's AGM held in June that year. I was co-opted onto the Federation's Executive Committee that year and I became a full EC member the following year and as they say the rest is history.

What advice would you give to anyone joining the tenant's movement today?

Make sure you have a strong voice as more voices together get more work done.

What has been your highlights of being involved with the Federation?

Seeing the positive changes that have been made for tenants' living conditions. Let's make sure these changes keep happening with everyone working together.

What has been your low points of being involved with the Federation?

Dealing with complaints against the Federation and EC members. Let's hope we never have to go through that again. Although as a result of this, ETF reviewed our Policies and Procedures which also included developing a Complaints Policy. So there were some positives from this.

What have you enjoyed most about being involved with your local group?

I'm very proud of the work SABRO has done in our local community. Some of our successes include ensuring all the properties in Southouse would be renovated as the Council initially only completed some of the houses in the area. SABRO campaigned for all homes in the area to have gas central heating and double glazed windows. This has made a huge difference to tenants' homes. We now have a new Community Centre in the area which our group had long campaigned for. It's great to see it being accessed by local people.

Any other comments?

I will miss being involved in the Federation's Executive Committee and I will miss the banter. Keep up the great work by showing the Council the right way things should be done.

TENANT LED INSPECTIONS

Well, what a busy few months it has been for our Tenant Led Inspection team. Firstly; our established Inspectors carried out an inspection of the Council's approach to insulating external walls. We sent a draft report to the Council with a number of recommendations on how processes could be improved and we will shortly be meeting with Council staff to discuss this in more detail. Once the report has been finalised, the Council will put together an action plan on how they aim to address the recommendations.

Secondly; our new Inspectors completed their learning modules, which included Dr Jo Ferrie from Glasgow University talking about developing interviews and questionnaires. Feedback from our learning modules was very positive.

The Inspectors are currently making preparations to carry out the next inspection which will be on an aspect of the Council’s Rent Collection Process. The inspection will begin in the next couple of months.

HUMAN RIGHTS ISSUES REPORTED TO THE COUNCIL

It’s been a busy few months for our human rights in housing project in West Cromwell Street, Persevere and Citadel Courts (WPC) in Leith.

The residents carried out a survey about issues in their area and results were present to Councillor Cammy Day, Council Officers and Ben MacPherson, MSP at a public meeting in June. Residents are looking forward to working with the Council to resolve the issues.

Dessie Donnelly from the Participation of Practice and Rights (PPR) organisation in Belfast was over for a visit to see how the project is progressing. PPR have successfully spearheaded human rights work with tenants in Belfast for many years, and are supporting WPC residents along with ETF and the Scottish Human Rights Commission (SHRC)

to assess and monitor their living conditions in relation to international human rights standards. Dessie met with residents in WPC to talk about what happened in the Seven Towers, Belfast and how residents of WPC can assert their human rights in practice.

Residents were also delighted to meet with three of the four Commissioners for Human Rights in Scotland to tell them about the project and take them on a walkabout of the area. The Commissioners have given their full support to the project.

Interested in finding out more about gas and electricity use in your home and saving money on bills?

Environmental charity Changeworks and the University of Edinburgh are looking for households in Edinburgh to participate in IDEAL, a two year, cutting edge research and advice project into home energy use. The benefits of getting involved include:

- Gaining insight into your home energy use;
- Receiving tailored advice from University experts;
- Possibly saving money on your gas and electricity bills.

Every household that participates will receive an Android tablet, used to display energy use information and for the University to communicate with you. In addition, you will be able to use the tablet as you would any other tablet during and after the research.



Households interested in participating would need to meet the following criteria:

- Based in Edinburgh (postcodes EH1-17);
- Property with a combi boiler and mains gas supply;
- Have home broadband;
- No prepayment or smart gas meters (smart electricity meters ok);
- Not planning on moving home before June 2018.

Participation in IDEAL involves:

- A two hour visit to your home; incorporating a short survey and the fitting of sensors measuring energy and heating use, light levels, temperature and humidity;
- Keeping the equipment in the property until June 2018 and reporting any problems;
- Responding to surveys and messages received from the University experts via the tablet provided;
- Leaving home broadband running 24/7 to allow the sensors to communicate;
- Saving energy and money through more efficient energy use and behaviour change.

COMMUNITY COUNCIL ELECTIONS

Edinburgh's Community Councils are looking for new recruits. By getting involved you can make a difference to what matters in your area, meet new people, learn new skills and help organise events that improve where you live.

The nomination period starts on 5th September and closes on 26th September 2016. Elections, where required, will take place on 27th October 2016. You can apply as an individual or as a local interest group, such as a Residents' Association or Registered Tenants' Organisation.

Councillor Maureen Child, Convener of the Communities and Neighbourhoods Committee, urged people to get involved: "Community Councils are a fantastic way of making the local authority aware of the needs of local areas. By getting involved, you can help your local area keep thriving. They are all about local residents working together to make a difference to where they live. In my experience, the best community councils and community groups involve folks of all ages and backgrounds, but they rely on people putting themselves forward. It may be a little daunting for those who haven't been involved in anything like this before, but help and advice is available."

What does a Community Council do?

Community Councils are made up of local residents and community groups such as youth forums, parent councils and student bodies. Each one is represented on the Neighbourhood Partnership for its area. They work with local elected members, Police Scotland, Scottish Fire and Rescue Service, NHS Lothian and the voluntary sector to identify and deliver local priorities.

There are 46 Community Council areas in Edinburgh, with more than 500 members. They receive an annual grant from the City of Edinburgh Council to support engaging with the local community, promotion and administration. They can apply for additional funding for projects and events to benefit the local area.

A Community Council:

- Gives local people a say on decisions that affect their area;
- Acts as a focal point for local groups building stronger communities;
- Consults with local people on issues that will impact on the community;
- Gets involved in a wide range of local issues including planning, licensing, community safety, health and well-being and environmental projects;
- Sources funding for local improvements;
- Organises community events and activities to improve the area.

GOING LOCAL!



For some time tenants have been telling the Council, their landlord, that they want to know their Housing Officers better and to be able to contact them more easily.

You may know that the Council is changing the way services are delivered to make sure that local services work better together to improve outcomes for tenants and communities.

The Council's Housing Service is moving to what's called 'patch working' where there will be around

100 Housing Officers managing about 200 homes each. The services will be delivered through four Council localities - North East, North West, South East and South West.

Each 'patch' will have one recognisable Housing Officer who will be out and about in the community making sure that they get to know their tenants. They will be responsible for carrying out a wide range of housing management tasks, including collecting rent, letting homes, dealing with repairs and helping tenants with any questions they may have.

This approach is a big change from the previous Housing Service focus on specialist staff teams. It seeks to bring the Council's locality model directly to tenants so that they will know their Housing Officer and their Housing Officer will know them.

We've already had strong support for this approach from staff, tenants' groups and ETF. Now we want to get your ideas on how these changes can be achieved and find out what you think will work well. NATIONAL NEWS

Social Security for Scotland Consultation

The Scottish Government has launched a consultation paper about how best to use the social security powers that will be devolved to the Scottish Government as part of the Scotland Act 2016. This is the start of a process that will define the way Scotland supports people who need assistance for generations to come.

We know that the benefits system affects many tenants, and welfare changes have deeply affected many ETF Members, so we think this issue will be one that tenants will want to get involved with.

Scottish Social Housing Charter

Members of Registered Tenant Organisations and individual tenants within ETF recently attended a review session on the Scottish Social Housing Charter. The aims of the session were to gain an understanding of the current Charter and discuss what needs to be included in the forthcoming new Charter. There were a number of lively discussions around themes, including:

- Do tenants currently have enough information to hold their landlords to account for their decisions and performance?
- How are tenants becoming involved in Charter reporting and monitoring?

The session was facilitated by ETF's Development Worker Mark Henry and Michael Boal, Scottish Housing Charter & Regulation Manager, Scottish Government. ETF has submitted a response to the Charter and here are some of the main points raised by ETF.

“Tenants don't know enough about the Charter.”

“ETF would like to see landlords encouraging tenants to take part through tenant scrutiny.”

“Tenants don't have enough information on what their rent money is being spent on.”

“Tenants want to be involved in value for money discussions with landlords.”

ETF welcomes end of Right to Buy

ETF welcomes the end of the Right to Buy (RTB) as a historic day for housing in Scotland as the scheme was scrapped by the Scottish Government at the end of July.

Introduced in 1980 by Margaret Thatcher's Government as a way to enable Council tenants to buy their homes at discounted rates, nearly half a million homes were sold in a loss to the social rented sector described as “devastating” by Convenor of ETF, Betty Stevenson.



The end of the policy has been warmly welcomed by the housing sector in Scotland, with landlords, third sector organisations and tenants all supporting the move that will help regenerate Scotland's social housing sector.

Betty said, “The end of the Right to Buy in Scotland is great news for Scotland's tenants. It can bring a rebirth of Scotland's social housing sector by protecting our stock for future generations. Not losing our housing stock to the RTB means there is an opportunity for investment in much needed affordable housing. ETF is delighted that new Council homes are being built for the first time in a generation and we fully support the Council's ambition for much needed affordable homes in our city.”

National Panel of Tenants and Service Users



The Scottish Housing Regulator (SHR) has a National Panel for Tenants and Service Users. Anyone who is a tenant of a social landlord, are homeless, a homeowner receiving factoring services or common repairs, or a Gypsy/Traveller using a Council or housing association site can join. The Panel is a way for the Regulator to hear people's views. Panel members will be asked their opinion in occasional surveys and other ways. To join the Panel contact

National Panel Survey Report

This year's report on tenants' views about their priorities and experiences as users of social landlords' services is out now. Here are some of the main points tenants and service users have made.

- All landlord services are seen as important by service users;
- Nationally, tenants have said the most important services they use are repairs and maintenance, keeping buildings and entrances secure and dealing with antisocial behaviour;
- Value for money for rent is the most important aspect of service for tenants. Tenants want to be able to see a difference for the rent money they pay and be clear about how charges relate to services;
- Communication from landlords is important for tenants;
- Housing costs and condition of homes were issues for 75% of tenants;
- Most tenants who responded have seen their landlord's performance information, find the information useful and know how to make a complaint to their landlord;
- Less than half of the respondents had heard of the Scottish Social Housing Charter whilst more than half had heard of and value the work of the Regulator;
- Value for money is important to tenants and tenants judge this by the quality of service received, investment in homes, affordability and the size of the rent increase;
- 80% of respondents said they had concerns about future affordability of rents caused by rent increases or changes to their income;
- Tenants want the Regulator to focus on rent and service charges and more effective tenant scrutiny as priorities.



These are important results for tenants and ETF will take up some of the points raised by tenants nationally with the City of Edinburgh Council, since they reflect what tenants have been telling the Federation locally, particularly with regard to improved tenant scrutiny and value for money and affordability of rents.

Suicide prevention in Scotland

“When it comes to suicide prevention, everyone can be a life saver.” That’s the message that Edinburgh’s suicide prevention coordinator Alan Laughland wants everyone to take home.

Choose Life coordinator Alan Laughland says, “People can sometimes be concerned that if they say something, it will make matters worse. This is a myth. Research shows that people who survive a suicide attempt are often crying out for help. Asking someone whether they have suicidal feelings is the first step to saving someone’s life. Then you can connect them with someone like the Samaritans or a GP who can help.”

Alan says, “The suicide prevention skills training programme has never been so extensive. This year to date; training has been delivered to professionals, volunteers, school children and at risk communities. Last year around 500 people received this training and Edinburgh is on course to exceed that figure this year. Three ‘suicide alertness’ safeTALK trainings will be delivered during this year’s Suicide Prevention Week alone. Choose Life is also now working in partnership with an academic researcher to work out how to make suicide prevention activity even more effective.”
