The Poverty Alliance recently carried out research on experiences of poverty in Edinburgh on behalf of the Edinburgh Poverty Commission. #### Reporting Repairs Online

Research by CEC has indicated that more and more tenants are taking up the option of reporting their repairs online. If you are interested in this method of reporting repairs this can be done by following these three steps:

- Visit <u>www.edinburgh.gov.uk/councilhouserepairs</u> and click on the button 'Request a Council home repair';
- 2) When you click on the button the first thing you need to input is your housing property number (UPRN). If you don't already know what it is, you can find it at <a href="https://osg.scot/portal/">https://osg.scot/portal/</a>;
- 3) You type in your address (or just postcode and select your address) and then click on your address to find your UPRN, which you will then have for future repair reporting. Reporting repairs online is designed to be quicker and to cut out telephone waiting time.
