The event will provide organisations with an opportunity to learn about the Universal Credit full service, what support is available to claimants, as well as offering you the chance to raise any questions.

## Upgrading the street lights across Edinburgh

Many of Edinburgh's street lights are no longer made and can't be maintained. So, CEC is upgrading them to energy efficient ones which are better for the environment, cheaper to run, give off a clearer light and can make streets feel safer. CEC is also putting in a new street lighting control system at the same time. This will help them identify faulty lights quicker and without people needing to report them. Work will begin towards the end of the year and is planned to be completed by early 2021. It should only take around 15 minutes to replace each light and since the street lighting columns are generally not being replaced, the work shouldn't cause people any disruption.

#### What changes will I see?

The light will look different. It's whiter and clearer than the more orange light we are used to, but it is not a blue light. There's also less light spill, lighting up roads and pavements better, rather than escaping upwards or shining into people's homes or gardens.

#### Making our streets feel safer at night

- Less glare and dazzle, lighting up a street more evenly; •
- It's easier to see colours, making it safer for people driving, walking and cycling; •
- The clearer light improves the quality of CCTV images.

#### Better for the environment:

- Use 60% less energy and reduce the Council's carbon footprint; •
- Reduce light pollution and provides a better environment for birds and wildlife; •
- No ultraviolet light reducing the attraction of night time insects;

Almost 100% recyclable and don't contain any harmful substances.

#### Cheaper to run and maintain

- They last up to five times longer than existing lanterns;
- They shine for 100,000 hours, 25 years; ٠
