### Who Can Apply?

Any registered Scottish Charity or constituted community group can apply for funding, provided they are based in Edinburgh and focus their activities within the city.

The OneCity Trust is keen to support small and medium-sized organisations. Therefore, preference will be given to organisations with an overall income of less than £500,000 per year. However, organisations with an annual income of more than £500,000 are not excluded from applying and their applications will be considered.

Applications from partnerships or consortiums are welcomed, however one of the partners must apply as the lead organisation who will be accountable for the grant.

Organisations who have previously received OneCity Trust Main Grant funding can apply again, provided their application is for a completely different proposal than that which was previously funded.

OneCity Trust is unable to offer repeat funding.

### Timescale of projects

- The OneCity Trust generally awards funding for projects lasting up to one year.
- Projects which use their award to deliver a project over a longer period will be considered.
- OneCity Trust is not able to provide repeat or multi-year funding.

### What size of grant can be applied for?

- Amounts requested should be between £5,000 to £10,000.
- If you have a project idea which requires a smaller amount of funding, you may be able to apply via the OneCity Trust's Lord Provosts Rapid Action Fund.

### How much is available?

In 2022 the OneCity Trust anticipates it will distribute between 10 - 17 grants of between  $\pm 5,000$  and  $\pm 10,000$  each.

### Insurance

Successful applicants are responsible for all insurances and liabilities to third parties that may be incurred during the course of the funded project.

### The Trust does not fund.

- Requests from individuals or non-constituted groups
- Projects or initiatives being undertaken exclusively by bodies constituted as statutory or other public-sector organisations.
- Projects or initiatives whose predominant benefits are the marketing of corporate or for-profit brands.
- Projects or initiatives supporting the promotion of faith groups, religious or political beliefs.
- Projects or initiatives looking for repeat or multi-year funding.

### To maximise chance of success

#### Applicants should clearly

- Identify the nature and level of need being addressed. Articulate what will happen (the outputs)
- Demonstrate clearly, the impact that will be achieved (the outcomes)
- Identify the numbers of beneficiaries.
- Identify the area(s) of the City of Edinburgh your project will serve. (The OneCity Trust will consider applications from all areas of the city, not just those identified as disadvantaged).
- Demonstrate that the proposal does not duplicate existing services.
- Highlight how the proposal alleviates poverty, encourages collaboration, participation or brings different people and communities together.

- Tick the boxes on your application form if you would like to be considered for funding from any of our community benefit funders.
- Return the completed application form with evidence of a bank account in your organisations name, current audited accounts and copy constitution if not a registered Scottish charity.

### How to Apply?

All applications must be submitted on the OneCity Trust's own application form, which can be requested by emailing <u>admin@onecitytrust.com</u>

The completed application form and accompanying documents should be emailed to <u>admin@onecitytrust.com</u> by 5pm on Friday 5 May 2023.

### **Funding Priorities**

The mission of the OneCity Trust is to fight inequality and exclusion in the City of Edinburgh. It is an independent charity which is uniquely linked to the city.

The Trust was established in 2003 in response to the OneCity report of the Lord Provost's Commission on Social Exclusion. It uses the idea of a 'community foundation' to give people and organisations a means to reach across the divides of the city and support what may well be very small groups at "grass roots" level.

The OneCity Trust has identified three themes as its priorities (pages 6 - 7) and any application should describe their work relating to at least one of the themes:

### 1. Social Inclusion

Addressing the barriers to social inclusion can take many forms and in the City Of Edinburgh in September 2020 the Edinburgh Poverty Commission reported on their findings into an extensive inquiry into poverty in the City, <u>A Just Capital Actions to End Poverty in Edinburgh</u> and is a call to action for everyone in the city.

It noted that poverty can be found throughout the city and not just what is known as 'deprived' areas and it is clear this has been exacerbated by the impact of the COVID19 pandemic.

Taking this into account projects and initiatives will align with achieving social inclusion and poverty reduction. The list is endless, but some examples might be the provision of debt & benefits advice, illiteracy and other support services. It might be helping with new home start-up kits, food pantries and food bank networks or fuel poverty. Or perhaps projects supporting mental health for all and fighting data poverty with IT equipment and training on software packages.

### 2. Cultural & Community Bridging

The OneCity Trust wants to create bridges between people, communities and organisations which are usually separated by a 'cultural' divide. The Trust views the word culture in its widest sense – sometime described simply as a shared awareness of 'the way we do things round here' – and does not restrict it to issues of national, ethnic, or socio-economic culture etc.

Cultural bridging can occur where projects and organisations: /...

Cultural bridging can occur where projects and organisations:

- Encourage people from a wide range of different communities and backgrounds (e.g., different ethnicities, generations, socio-economic background, and abilities to break down barriers and come together and create greater understanding and mutual connections).
- Ensure their activities are inclusive and open to all, improving access to those services and proactively ensuring their staff have the skills to be inclusive and welcoming.
- Make it possible for people to come together from across real or imagined 'divides' to access services or carry out activities together for their own and their mutual benefit or enjoyment.

### 3. Civic inclusion

The OneCity Trust want to promote active citizenship and further developing civic society, promoting work which reflects the growing cultural diversity of the city, celebrates our differences and our commonality, leading to a genuine desire in every citizen to engage in tackling the inequalities which hamper our collective social and economic potential. We want to create a more socially just city.

Civic inclusion can be promoted when projects and initiatives:

- use the characteristic uniqueness of Edinburgh to bring people together from across the city to look to build a sense of identity and to articulate the specific ways in which the citizens connect to Edinburgh.
- encourage the sharing of different viewpoints within the diverse but connected community of the city (young, old, students, visitors, city-Centre, city-outskirts, etc.,).

### **Community Benefit Funding Partnerships**

#### Community Benefit Legacy funding from Travis Perkins Managed Services / City of Edinburgh Council

TPMS was awarded a contract with the City of Edinburgh Council (the Council) which commenced on 1 April 2022 to supply all building and repair materials. This contract was on a 7 (seven)-year plus 3 (three)-year basis. As part of their community benefit commitment, they are working with the OneCity Trust to provide additional funding to projects in the city.

TPMS is interested in funding projects which directly benefit City of Edinburgh Council tenants but will consider projects serving geographical areas with a high proportion of Council homes. If, your organisation involves City of Edinburgh tenants, or your project will serve geographical areas with a high proportion of Council homes.

### Community Benefit Legacy funding from Robertson Construction Group / City of Edinburgh Council

Robertson Construction Group (Robertson) was awarded a £15m contract with the City of Edinburgh Council (the Council) for a new community hub at Macmillan Square, in partnership with North Edinburgh Arts (NEA), as part of the Council's ongoing multi-million-pound regeneration programme in North Edinburgh. As part of this contract Robertson will provide a total Community Investment Fund of £10,000.

One City Trust (OCT) was approached by the Council and Robertson to discuss whether OCT was a suitable route through which these Funds could be managed and disbursed for projects which it funds to reach charitable organisations who are based in or have a presence in Pennywell and Muirhouse area.

# Community Benefit Legacy funding from CCG (Scotland) Ltd / City of Edinburgh Council

CCG (Scotland) Ltd (CCG) was awarded a contract with the City of Edinburgh Council (the Council) to develop the district of Granton, a key area of regeneration that will see over 3,000 mixed-tenure, 'net zero carbon' homes, as well as new schools and transport infrastructure, set to be created as part of the Granton Waterfront Development Framework by constructing the 444-home development. As part of this contract CCG will provide a total Community Investment Fund of £10,000.

The OneCity Trust (OCT) was approached by the CEC and CCG to discuss whether OCT was a suitable route through which these Funds could be managed and disbursed in areas within North Edinburgh.







### Community Benefit Legacy funding from CGI UK Ltd / City of Edinburgh Council

We are able to offer applicants the opportunity to have their grant application considered for a dedicated fund with CGI UK Ltd (CGI). There is no direct financial benefit awarded to applicants, but CGI will use their technology and business consulting expertise, where they can, to deliver pro bono Information Technology (IT) work for local charities and community organisations in the City of Edinburgh.
