Does your tenants' group involve City of Edinburgh Council tenants? Would you be interested in applying for a grant for a social inclusion project?

The OneCity Trust is running a social inclusion grants programme. Grants are available to constituted groups and small charities in the city. Two sizes of grant are available: larger grants of between £5,000 and £10,000, and also small grants of up to £2,000. This year, the Trust is particularly looking for applications from tenants' groups which involve City of Edinburgh Council tenants.

An information evening will take place on **Thursday 17<sup>th</sup> March 2016, Dunedin Room, City Chambers, High Street**, **7.00pm-8.30pm** and will cover the following:

- The OneCity Trust's two grant programmes for social inclusion projects: the priorities, how much is available and how to apply;
- The partnership between the Council and Travis Perkins Managed Services and the Trust: what kind of projects Travis Perkins want to fund;
- The support your group can access from ETF to make an application and see your project through.

The deadline for applications is **Friday 29**<sup>th</sup> **April 2016**, so you will have six weeks after this event to discuss with your group and make a decision about applying.

The Scottish Housing Regulator (SHR) is looking to recruit 12 tenant advisors who will help provide a tenants' perspective in its work. The Regulator wants to understand what is important to tenants and this is why it is looking to appoint volunteer tenant advisors to provide it with a tenant's perspective. Tenant advisors should be reflective of social housing tenants in Scotland and so the Regulator welcomes applications from people of all ages, backgrounds, communities and areas. It encourages applications from under-represented groups including ethnic minorities, disabled people and lesbian, gay, bi-sexual and transgender people. The Regulator will be working alongside the Tenants Information Service (TIS) to support the recruitment of tenant advisors.
