ETF statement on Coronavirus

Edinburgh Tenants Federation (ETF) is pleased to let you know that we continue to operate during the Coronavirus (COVID-19) outbreak. In line with Scottish Government guidance, the office base is currently closed and staff are working from home but can still be contacted in the usual ways – by email to info@edinburghtenants.org.uk or by phoning 0131 475 2509 and they will do their best to assist you. ETF's Convenor Betty Stevenson commented, "I am proud of the role that our staff and volunteers continue to play during these uncertain times. While it is frustrating not being able to attend meetings and have a more hands on role, the safety of our staff and volunteers is vitally important. We will continue to keep everyone up to date on ETF's status and hope to see you all at a future event once this crisis is over." At present we are unable to say when staff and service users will be able to return to Norton Park. We will take advice from the Scottish Government and the Albion Trust on this matter.
