

Our work in other subgroups such as stair cleaning, high flats, housing retrofit plans, among others, helps us work with the Council to try to improve housing conditions and standards.

We are really pleased to see that local tenants' and residents' groups are thriving once again and are working hard to improve their local communities, and delighted to see that some new groups are being set up.

Through our meetings with MSP's, the Scottish Government, and other organisations interested and involved in housing issues and services, we are making sure the voices of tenants living in Edinburgh are being heard, including people living in temporary accommodation, whilst waiting for a home of their own.

We would like to thank the City of Edinburgh Council for its continued support and funding and our staff and TIS for supporting the Federation to achieve its aims and objectives.

Communications and Social Media

ETF has been working on improving its social media presence during 2023, including taking part in several social media campaigns to support relevant issues and raise awareness of the organisation. This includes Volunteers Week, Small Charity Week and Challenge Poverty Week. In addition ETF has created useful and interesting content for social media, such as promoting events and sharing partner's work and information. There has been a steady increase in followers, reach and engagement in ETF's social media this year. ETF has ambitious plans for developing its communications and use of social media in 2024, as part of a wider rebrand and update of the organisation's digital communications.

Round Table Meetings

ETF hosted two Round Table events in January and August 2023. Councillors from all parties were invited to attend and engage with tenants on topics chosen by the tenants, which they had identified as priorities. Both events were well attended and successful and as a result will hopefully be replicated in 2024. The January session focussed on New Builds, Communication between the Council and tenants, Allocation of Council Housing, Void Management & Timescales, Value for Money, Housing Investment Needs and Targets, Repairs and Maintenance. The August Round Table covered Council Performance Targets, Housing Service Strategies, Housing



Legislation, Sheltered Housing, Housing Improvements, Voids and Allocations and Rent Setting and Affordability. Scrutiny Update

Following on from the Tenant Participation and Scrutiny Framework review in partnership with the Council and Tenants Information Service, two new scrutiny subgroups have been set up. One has a focus on repairs and maintenance and the other focuses on Sheltered Housing. Supported by ETF and TIS staff these meetings provide ETF members and individual tenants the opportunity to meet with CEC officers, to find out more about these services, give their views, advise of issues and concerns, and suggest how things could possibly be improved.

And during 2024 / 25, ETF plans to recruit more tenants to get involved in a **new scrutiny group**. Tenants will be invited to come along to find out more about scrutiny, how they can get involved, the types of activities tenants could undertake to carry out in depth, independent reviews of agreed housing service, policy, and procedure areas. Look out for more information on scrutiny opportunities in Spring / Summer 2024.



Volunteer Fair

ETF hosted a stall at the very successful Edinburgh Volunteer Fair on Wednesday 13th September 2023. ETF used this excellent opportunity to speak to members of the public and partner organisations about the work of the Federation and to raise understanding of tenant participation and tenant scrutiny. It was also useful for ETF to find out more about some of the great work that other organisations are doing, and how they utilise volunteers in this work. ETF hopes to attend the volunteer fair again next year.

Out and About at Community Events

ETF has participated in several community events this year, including Goodtrees Carnival and Broomhouse Street Party in the summer. These were great occasions to meet tenants and residents in different areas of Edinburgh, promote the organisation and explain how people can get involved or get support from ETF. Both events also offered excellent opportunities to connect with other partner organisations who were also stallholders.



ETF also attended community meetings with Low Income Families Together (LIFT) and Shelter Scotland to look at improving housing conditions, and another with End Poverty Edinburgh focused on how partners can work together with the community to campaign against and challenge poverty in Edinburgh.

International Union of Tenants Membership

In June 2023 the International Union of Tenants (IUT) accepted ETF's membership application, which allows ETF to access a great range of events and resources from the IUT and member organisations across the world. It will be fantastic to learn more about how tenants' rights and tenant participation and scrutiny are carried out within a worldwide



perspective. We look forward to finding out more about the quality and availability of social housing, provision of housing services as well as the wider housing issues and concerns that can impact any country. We hope to share and learn from good practice and look forward to keeping you up to date on developments going forward.

Scottish Government Human Rights Bill Consultation

ETF members and tenants met in October 2023 to discuss and seek views on the Scottish Government's Human Rights Bill consultation. Following the session, ETF submitted a response to the Scottish Government focusing on:

- Dignity in housing, what this means and how the Scottish Government would describe dignity.
- · Standards of living and housing conditions.
- · Having a minimum core obligation that landlords should meet in terms of human rights.



The United Nations Committee on Economic, Social and Cultural Rights states that housing is the basis of stability and security for an individual or family. The centre of our social, emotional, and sometimes economic lives, a home should be a sanctuary—a place to live in peace, security, and dignity.

Damp and Mould



At the Federation meeting in April 2023, Sharon Donohoe of TIS presented on the topic of Damp and Mould in housing. This has been a much-highlighted issue in recent years following the tragic death of Iwab Ishaak in Rochdale in 2020, where an independent enquiry concluded that the toddler's death was a direct result of damp and mould in his home and the failure of the Borough Council to address it. The enquiry also led local authorities and wider social landlords in Scotland to review their damp and mould policies.

The Federation meeting outlined different types of damp and mould and their causes and provided tenants with the opportunity to discuss their experiences and share views. Following this, the City of Edinburgh Council created a new Damp Team and has been recruiting specialist staff to work within it to improve the Council's responses and effectiveness when dealing with damp and mould reports from tenants. Further partnership work will be developed between ETF, TIS and the Council in the coming months.

All-Party Parliamentary Group Council Housing Inquiry Consultation

ETF worked with a group of tenants in early October 2023 to provide detailed feedback to a UK wide All-Party Parliamentary Group (APPG) which was conducting a Council Housing Inquiry. This was a successful event and the information gained from the group was passed back to the APPG, as well as later being distributed to MSPs for Edinburgh. ETF highlighted the need for the continued and increased support for Council Housing, increased investment requirements and availability of Council homes, both in Edinburgh and across the



country. ETF hopes to be included in any further correspondence related to this Inquiry, so that we can inform tenants, officers, Councillors, MSP's, and MP's and to ensure tenants' voices are heard and acted upon.



Tenant and Landlord Rented Sector Reforms Consultation

In October 2023 ETF held a session for tenants to discuss, seek views and respond to the Tenant and Landlord Rented Sector Reforms Consultation. The consultation focus was mainly on the private rented sector (PRS) with a smaller focus on the social rented sector (SRS) of council and housing association housing and services. The SRS questions and discussions focussed on the rights of tenants to have pets, how protections around evictions can be improved and what unclaimed tenancy deposit money should be spent on.
